

# Wyonegonic Health Center Reminders

## Changes in your camper's health status or medication:

- Any changes to previously submitted and electronically signed forms related to health status, exposure to communicable disease, or medication must be communicated to the Health Center using the contact details listed below.
- Information regarding changes should not wait until arrival day.

## Immunizations:

- Due to elevated interest regarding measles in the United States, The State of Maine Department of Health and Human Services has issued an update of ***recommended actions to summer camps in regard to immunization record histories***. Please ensure that we have appropriate health records on file for your camper. Those requesting a waiver of immunizations based on religious grounds, should contact the camp office to request the waiver form.

## Medication:

- Written medical orders are required for all prescription and OTC medications- including vitamins, supplements, and herbal remedies. Please ask your healthcare provider to include medication orders on the Physician Exam Form that needs to be completed for each camper. The form can be downloaded via the Parent Login which can be accessed from our homepage [www.wyonegonic.com](http://www.wyonegonic.com).
- With the exception of inhalers, Epipens, nasal sprays, liquid medicines and medications prescribed outside of the United States, all prescription and over the counter (OTCs) medications must be arranged by establishing an account with CampRx. Visit [www.CampRx.com](http://www.CampRx.com) for more information and to register your child.
- Acknowledging the exceptions listed above, **Medication that is not ordered through CampRx will not be dispensed at camp.** Contact the Health Center (see contact details below) if you have questions.
- Wyonegonic covers the registration fee for CampRx, However, parents will be responsible for late fees related to last minute medication orders.

## Insurance:

- Please remember to provide a photocopy of the front and back of your medical insurance card. If your prescription plan requires a separate card, please include a copy of the RX card with the RX bin#.
- You can submit a copy of your health insurance card by uploading a scan to the Parent Login on our website (preferred method); or by postal mail, pdf attachment to [info@wyonegonic.com](mailto:info@wyonegonic.com) or fax (207) 452-2611.

## Head Lice:

- Every camper will be screened for head lice by *Lice Treatment Center* professionals on opening day. If your child is found to have lice or nits *LTC* will also provide lice treatment and nit removal.

- Parents are responsible for treatment fees, so please be sure to check your child's hair and scalp before arriving at camp. This will avoid time-consuming and costly treatments and will avoid delays in opening day activities for your camper.
